   We will need to confirm and record the name of all attendees. If a participant cannot be identified, they will be removed from the meeting.
- 3. Once the meeting starts, attendees will be given the instruction to turn off their camera if they desire to improve bandwidth.
- 4. If speaking, please activate your camera so other delegates can see who is speaking.

#### CUPE 38's Application to Alberta Labour Relations Board

In January 2021, CUPE Local 38, in conjunction with CUPE Locals 37 and 709 and IBEW, filed an application with the Alberta Labour Relations Board (ALRB) to challenge the Calgary Parking Authority designation as a separate entity from the corporation that is known as The City of Calgary. CUPE Local 38 believes that our members in CPA are City of Calgary employees and we've made application for common employer status. There has been ongoing discussion around this matter between the legal representatives of each group effected. As a result of those discussions, the City of Calgary legal representative has requested that the Board place this file in abeyance to allow the effected parties to negotiate a resolution to this matter. The Unions have agreed, as it is a benefit to our members to have the opportunity to resolve this ourselves as opposed to the ALRB dictating the outcome. If the parties can come to an agreement, that will be presented to the ALRB as the resolution. The ALRB will then ensure the agreement adheres to labour laws. and rule the matter resolved.

When a move is made to unionize a workplace, an essential step in the process is for the Union to apply to the ALRB for certification to represent a certain group of workers. Once approved, the scope of their representation is clearly identified in the resulting certificate. It is for this reason that there are several unions involved in these discussions. The intent is to ensure that the members impacted at CPA will become members of the local that best represents their type of work. This will likely result in some of our current members under the CPA collective agreement, moving into a different union local. All the listed locals are part of what we refer to as the Civic Coalition of Unions as they all represent municipal workers at the City of Calgary.

The review and determination process with the ALRB is lengthy and we will likely not see resolution to this application for several months. For this reason, CUPE Local 38 will be sending notice to the CPA advising of our intent to open bargaining, prior to the end of March 2021. It is important that we adhere to our timelines for this process in order to protect our right to bargain the current collective agreement with the CPA should the ALRB application be denied. We will be holding a special meeting to elect one delegate to the bargaining committee on March 27, 2021 via the online platform, Zoom. As per our Bylaws, the Sub-Local Chair, Faizan Khan, and the Recording Secretary, Sikander Masood will sit on the bargaining committee. Refer to the meeting announcement on the next page. If you have colleagues wanting to attend the meeting, but they did not receive this email, please advise them to contact our office at 403-233-2700 or at office@cupe38.org. We will be forwarding the meeting link via email so we require a personal email address to be able to send to members.

We will continue to rely on personal emails to communicate with our members at the CPA, so ensure we have your information. In the coming months, we will be sending out surveys to obtain input from members needed for the bargaining committee to structure their proposals. We will also be updating periodically on the ALRB application process through email, so don't forget to contact us with your personal email address.
