### **Zoom Into the General Meeting**

With the continuing restrictions on indoor gatherings by Alberta Health Services, the Executive of Local 38 has made the decision to cancel in-person meetings for April.

The April 27th, 2021 Annual General Membership meeting will be held through a on-line Zoom meeting. We encourage every card-carrying member to contact the office for the specific details to attend the meeting.

In an attempt to balance the confidentiality of the meeting with access for our members, we are asking the following:

- 1. Contact the Union Office at 403-233-2700 or office@cupe38.org to obtain the access code for the meeting.
- 2. When entering the Zoom meeting, please ensure your camera is on and that you identify yourself. We will need to confirm and record the name of all attendees. If a participant cannot be identified, they will be removed from the meeting.
- 3. Once the meeting starts, attendees will be given the instruction to turn off their camera if they desire to improve bandwidth.
- 4. If speaking, please activate your camera so other delegates can see who is speaking.

I want to thank everyone for their understanding during these times. While we prefer in-person meetings, to ensure the health and safety of our members, online meetings are needed to continue the democratic operations of our Local.



### **ENMAX Redeployments**

Redeployments at ENMAX are ongoing. The Union has been advised that Human Resources is currently about half way through the list of positions that were originally identified for elimination. Anyone familiar with the redeployment process knows, that the original list of positions to be eliminated is not the end of the impacted positions. Redeployment most often results in a bumping process that then creates a secondary list of impacted members. The good news is that list is also half way through the placement process. The ENMAX redeployment team has advised us that they are currently working with members that have 9 years or less in seniority, which is about half way through.

As this employer is working on the reallocation of labour resources, many work groups are finding gaps in their teams and new postings are being established frequently. The redeployment team has committed to ensuring members on the redeployment list are considered prior to any placements in these new positions. This can seem like a juggling act with many balls in the air, and it's not a perfect process. Some of our members have received positions that they are quite happy with, while others will use this opportunity as a stop-gap to their next ideal position.

There is no question that the redeployment process can be disruptive and stressful, but the intent is to keep our members working for this organization with some wage continuity and opportunities for advancement in the future. The hope is that, in the future, this employer will explore all other options prior to eliminating jobs. We all know that the work still exists and in some areas has increased. Once this restructuring process is complete, everyone can get back to getting the work done.
