

AimCo and Our Pension

There has been a lot in the news recently about the investment firm for the provincial government. AimCo was set up to manage and invest provincial money, and as part of this mandate the Local Authorities Pension Plan and Public Sector Pension Plan are required by law to use AimCo as their money manager.

Under the previous Notley government, the legislation was changed to allow LAPP Board of Trustees to make the decision as to which manager they would use for investments. One of the first moves made by the incoming Kenney government was to repeal this part of the legislation and force LAPP to stay with AimCo. Additionally, the Kenney government required the Teacher's Pension Plan, which was always independent from AimCo, to now use only AimCo for investments.

The recent news of the AimCo's loss reinforces the need for our pension plan to have the ability to choose their own investment manager. According to the news, AimCo lost upwards of \$4 Billion in realized and unrealized losses when they invested in derivatives (investments that pay off only if stock prices remain stable). Fortunately, the losses have largely been from the Heritage Trust Fund rather than our pension plan. The LAPP Board has in place a statement of investment principles and policies that mitigates against such volatility. The Pension Plans told AimCo to limit their exposure to strategies tied to market volatility. Due to this, LAPP and the other pension plans were protected from the losses.

As a pension plan member, we have the security of a defined benefit plan. However, as an Albertan, we should all be concerned that AimCo is making poor decisions with our money. According to the Globe and Mail, the AimCo executives were not fully aware of the risks they were taking. While derivatives are complex at the best of times, it is unacceptable that AimCo is taking risks with our money without fully understanding the implications.

It is critical that any true plan independence must include the ability of the Board Trustees to make the decision on investment managers. The Unions participating in the plan continue to lobby the provincial government to make our plans truly independent. But we need your help. Tell your MLA to make the changes necessary to protect our plan. Tell your MLA to take the politics out of our pension!

Annual General Meeting Postponed

The Local 38 Executive Committee has made the determination to postpone the Annual General Meeting scheduled for April 28th. Local 38 Bylaws empower the Local 38 Executive Board to continue the operations of the Local in between general meetings. Given the extraordinary circumstances surrounding COVID -19, it is not feasible to hold the regular general meeting. The Executive Board is meeting on-line and will make a determination regarding future membership meetings at the beginning of each month.

The April Annual General Membership meeting is normally dedicated to Local 38 elections. As stated in previous editions of the CUPE Connection, to be eligible for the office of President, Treasurer and Chief Steward, members interested in running for these positions were obligated to announce their intention to run at the March Regular Meeting. Due to restrictions in place regarding COVID-19 the scheduled March 24, 2020 Regular Meeting was cancelled.
