Safety Boots

We have received numerous calls at the office regarding the current reimbursement level for safety boots. The main complaint is that the current maximum \$140.00 fails to provide adequate reimbursement for a reasona-



ble pair of steel toed boots. Based on these concerns, a Local 38 Officer went to Mark's Work Wearhouse and confirmed that there is a very limited selection available within the price limit.

The Local contacted Human Resources to discuss adjusting the limit, given that this amount has remained unchanged for 10 years. The response from the City was that they are unwilling to address this matter, due to concerns that other civic unions would want a similar increase in their boot allowance.

There is a significant difference between our collective agreement and many of the other Civic Union's agreements. Article 206.02 of our collective agreement requires the City to provide all permanent employees with safety equipment at no cost. The fact that this includes safety boots was affirmed by an arbitration award in the early 1980's. For ease of administration and to provide member's choice in footwear, Local 38 agreed to a cap of \$140.00. It was our understanding that this cap would reviewed over time.

Calgary Crush!

In an amazing election upset, the Alberta New Democrats swept the majority of Calgary seats, and have formed the new majority government in Alberta. In the initial opening of the election in Calgary, Joe Ceci was the acknowledged front runner in Calgary Fort. Joe represented many Calgary Fort communities as an Alderman for 15 years, and is widely respected throughout the riding. At the outset, Joe was considered to be a star candidate, set to make a breakthrough in Calgary for the New Democrats.

And in the end, Joe took half the vote in Fort. With significant experience in elected office, Joe is best positioned to represent members of Calgary Fort in the Legislature.

What is surprising to many was the overwhelming support of Calgarians for the New Democrats. It became apparent late in the election period that frustration and anger of Calgarians towards the governing Conservatives was reaching a boiling point. The result is that over a dozen NDP MLAs will now be joining Joe in the Legislature to represent Calgary in the new majority government.

This election victory is a tribute to the New Democrats and their clear message that it is time for change in Alberta. Support for the New Democrats spanned the entire province, with NDP MLAs heading to the Legislature from Medicine Hat, Lethbridge, Red Deer, Peace River, Hinton, Banff, Calgary and Edmonton.




Reminder to get your 1,000 word essay on <u>one</u> of the following topics:

The City may decide to have Supply Management establish an inventory of safety boots or set up a contract with a retail supplier. Regardless of their decision, safety boots will need to be provided at no cost to you the member. It is also our view that to purchase or pick up boots is work and, therefore, we encourage all members to get their boots during their normal work hours.

Local 38 has picked up discount cards for Mark's Work Wearhouse to help offset the reimbursement shortfall during the notice period. If you require boots, or just want a discount card, call the office at 403-233-2700 and we will provide one to you.

Given the City's refusal to provide appropriate reimbursement, there will be a motion brought forward at the May Regular Meeting to end the current practice and revert to requiring the City to provide employees with safety boots at no cost. We are required to provide reasonable notice, which will allow the City to decide how they are going to deal with this issue.

Send your kid to camp!

The Alberta Federation of Labour is holding its 19th Annual Kids' Camp August 3-7, 2015 at the Goldeye Centre near Nordegg on Goldeye Lake.
