Redeployments

We have had many enquiries regarding the bumping process. It may be helpful to review the collective agreement and Article 23.03 which deals with the matter. The first step is to place an impacted member in a vacant position at the same pay grade. The second step is in the event there is no vacancy the employer will look at lower pay grades or the employee may bump the **most junior** employee at the same pay grade for which they meet the minimum qualifications.

As many of the calls have suggested; the senior employee does not get displaced only to displace a more junior employee within the position. To be clear, it is the junior employee that is impacted.

REMINDER: Half Day Christmas Stat

Employees who work regular hours starting at 8:00 am shall be required to work 1/2 of a shift on their last working day prior to Christmas provided that there are sufficeint staffing levels maintained to meet the requirement of ENMAX to stay open.

Employees who shifts commences prior to 8:00 am will be required to 1/2 of their shift provided there are sufficent staffing levels maintained to meet the requirement of ENMAX to stay open.

Employees whose shift commences after 8:00 am may have their start time adjusted for that day only, in order they are able to complete 1/2 of a shift on that day.

Any time required to be worked by an employee in excess of the 1/2 shift will be subject to the statutory holiday entitlements under Clause 34.05.
